Post cards have been mailed to 3200 voters. Walt noted that he has VR forms in the back of the room to hand out to those that want to pursue VR on their own as he has been very successful in this regard.

**SPEAKER** – Justin Berardino, from OC Registrar of Voters office provided an overview of the new Vote Centers and changes to the ways in which we can now vote and the reasons this is a more secure method.

Ted noted that Katie Porter will be the speaker at our March meeting.

**Political Action** – Vivien reported that her team delivered Valentines from our Club to Katie Porter and Mike Levin, and then wrote Valentines to Vets while at Katies office.
